

COMPLIMENTARY PARKING

Terms and Conditions

- 1) By participating in the promotion described in paragraph 3 below ('Promotion'), the participant agrees to accept these Terms and Conditions.
- 2) The Promotion is only valid from Mondays to Thursdays excluding Public Holidays, unless otherwise stated.
- 3) Complimentary parking coupons may be redeemed in either of the following ways:
 - (i) Participants must spend a minimum of S\$100 at participating stores within The Shoppes at Marina Bay Sands®, Hotel Lobby and Coach Bay, ArtScience Museum™ or ArtScience Museum Shop to redeem a complimentary parking coupon. Each complimentary parking coupon is only valid on the day of redemption for up to 6 hours, from the time of entry of the participant's vehicle into the car park. Any parking charges incurred after the 6-hour period shall be borne by the participant. A maximum of two (2) same-day receipts time stamped between 10am and 4pm may be combined to achieve the minimum spend of S\$100. Limited to one redemption per participant per day. Redemptions must be made by 5pm on the date of the relevant receipt. Receipts not redeemed by 5pm on the date printed on the receipt cannot be redeemed at a later time or date. Each receipt can only be used once for redemption.
 - (ii) Participants must purchase a minimum of two (2) tickets to any show in any category, held at the Grand Theatre or Sands Theatre within the MasterCard® Theatres to redeem a complimentary parking coupon. Redemptions must be made on the date of the show as printed on the relevant tickets before the show. Tickets not redeemed on the date of the show, as printed on the relevant tickets before the show, cannot be redeemed at a later time or date. Each complimentary parking coupon is only valid on the day of redemption for up to 6 hours, from the time of entry of the participant's vehicle into the car park. Any parking charges incurred after the 6-hour period shall be borne by the participant. Limited to one redemption per participant per day. Each pair of tickets can only be used once for redemption.
- 4) The complimentary parking coupon may be redeemed at any Retail Concierge counter within The Shoppes at Marina Bay Sands upon presentation of the original receipt(s) or tickets. Only valid original receipt(s) from participating stores located within The Shoppes at Marina Bay Sands, Hotel Lobby and Coach Bay, ArtScience Museum or ArtScience Museum Shop, and valid original tickets purchased from the box office at MasterCard Theatres will be accepted.
- 5) The following transactions are not eligible for this Promotion:
 - (i) Transactions at the following venues: Adrift, Banyan Tree Spa & Fitness Centre, Bread Street Kitchen, Club55, CUT, db Bistro & Oyster Bar, DBS, Far East Exchange, Flight Bar & Lounge, Hotel Gift Shop, Livewire by Singapore Pools, Osteria Mozza, Pizzeria Mozza, RISE® Restaurant, RISE Lounge, Sampan Rides, Skating Rink, Sky on 57®, Sands SkyPark®, SkyPark Shop, Spago, SweetSpot® and Waku Ghin;
 - (ii) Bulk and/or corporate ticket purchases from ArtScience Museum and MasterCard Theatres;
 - (iii) Casino and hotel room transactions;
 - (iv) Bill payments, instalment plan payments, and voucher and/or gift certificate purchases.

- 6) Marina Bay Sands ('MBS') reserves the right to disqualify any party that does not meet the Terms and Conditions of the Promotion. These include parties who submit entries with invalid receipt(s)/tickets or incomplete or incorrect information. MBS is not responsible for the loss of opportunity to participate if for any reason whatsoever a participant is unable to provide valid original receipt(s) or tickets.
- 7) All complimentary parking coupons are non-exchangeable, non-cashable and subject to availability on a first-come-first-served basis. Lost, damaged, defaced or stolen complimentary parking coupons will not be reissued.
- 8) At any time and without prior notice, MBS may amend these Terms and Conditions or terminate the Promotion and all participants shall be bound by such amendments or termination.
- 9) The following parties are not eligible to participate in the Promotion:
 - (i) Advertising agencies, tenants and affiliates of MBS;
 - (ii) Employees of MBS and their immediate family members.
- 10) By participating in the Promotion and/or accepting the complimentary parking coupon, each participant:
 - (i) agrees that MBS shall not be responsible for, and no claim relating to any losses or injuries (including special, indirect and consequential losses) shall be asserted against MBS, its parent companies, affiliates, directors, officers, employees or agents in relation to any and all losses, damages, rights, claims and actions of any kind resulting from the Promotion and the participant's acceptance or usage of the complimentary parking coupon, including without limitation, personal injuries, death and property damage; and
 - (ii) consents to the collection, use and disclosure to third party service providers by MBS, of any personal data provided by a participant to MBS in conjunction with the Promotion, for such purposes as MBS deems reasonably necessary for the administration, management and assessment of the Promotion.
- 11) Participants shall indemnify MBS against any losses, claims, demands, liabilities, costs and expenses for personal injury or death, loss, damage to property, breach of any obligations, warranty or representation, claims, fines and penalties, which may be imposed on or which MBS may suffer or incur or which may be made, instituted or asserted against MBS arising out of or by reason of negligent acts, omissions, fraud, wilful misconduct, or a breach of obligations, covenants, representations or warranties by the participant in connection with this Promotion.
- 12) In the event of any dispute, the decision of MBS is final and binding. Participants shall not commence any legal or other proceedings in any court or tribunal in any jurisdiction in respect of any such dispute.
- 13) A person who is not party to any agreement governed by these Terms and Conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any term of such agreement or these Terms and Conditions.
- 14) These Terms and Conditions shall be governed by Singapore Law.
