

Sands Rewards LifeStyle - \$1,000,000 Sands Super Lucky Number

Mechanics

- Eligible SRL members (“Eligible Members”) will be invited to play the Kiosk Game at any SRL kiosks in the Venue during the Kiosk Game Play Periods as set out in clause 3a.

Daily Kiosk Game Play

- To play the Kiosk Game, each Member is required to swipe his SRL membership card at any SRL kiosk within the Kiosk Game Play Period during the promotion period. Once a membership card is swiped, the Member’s kiosk game allocations will be automatically uploaded and updated into his membership account. The number of Kiosk Game plays allocated to the member is calculated by the SRL kiosk and is final.

The table below summarizes the details of the Members’ eligibility to get the number of Kiosk Game plays:

3. Earned Play:

- All existing and new Members will be entitled to get one Kiosk Game play with every \$300 or more spent before tax and service charges in a transaction at any Sands Rewards participating outlets (“Participating Outlets”) (<https://www.marinabaysands.com/sands-rewards-lifestyle/participating-outlets.html>) in MBS during the following Earning Periods:

- Spend refers to any spend, excluding goods and services tax and service charge (where applicable), made by cash, NETS, Members’ own credit card, Members’ own debit card or redemption of Destination Dollars.
- Each Qualifying Transaction is limited to only one Kiosk Game play.
- Members are limited to earn 3 plays per day.

4. Bonus Kiosk Game Play:

- MBS may, at its sole and absolute discretion, award additional plays as bonus (“Bonus Play”) to Members pre-selected by MBS (“Pre-Selected Members”).
- The Pre-Selected Members will be sent SMSes and/or electronic direct mailers from MBS, explaining their eligibility to redeem their Kiosk Game plays
- Eligible Members shall be entitled to redeem a minimum of one (1) Kiosk Game per day, as set out in the respective terms communicated to each of the Eligible Members during the promotion period from 5 April – 23 May 2021.

5. One-Time Kiosk Game Play:
 - a. Newly signed up Members can be qualified to redeem one (1) Kiosk Game play, as communicated to such Members via SMS and/or electronic direct mailer.
 - b. Such Members must have signed up for an SRL membership and successfully completed an OTP verification process within 24 hours of sign up during the same Earning Period to qualify.
6. All Members meeting the eligibility criteria for the Promotion can redeem the Kiosk Game play earned or awarded during an Earning Period by swiping their SRL membership card in person at the designated kiosk machines during the corresponding Kiosk Game Play Period set out in clause 3a. above.
7. Any Member who fails to comply with any of the Rules will have their option to redeem their play forfeited.

8. Upon swiping at the kiosk, Members are entitled to choose any 4-digit combination between numbers 0000 to 9999, (hereinafter referred to as '**Chosen Number Combination**').
9. The kiosk will generate a kiosk slip with Members' Chosen Number Combination printed on it.
10. Members can participate in a Kiosk Game draw promotional session as stated on the kiosk slip. The Kiosk Game draws will be located within the Venue.
11. Members must utilize their Kiosk Game play(s) no later than 11:59pm on the day of which those Kiosk Game play(s) were allocated. Failure to do so will result in forfeiture of the Kiosk Game play(s).
12. **One (1)** set of 4-digit combination (hereinafter referred to as '**Winning Number Combination**') will be drawn Every Sunday at **1pm** and the draw results will be displayed on the Marina Bay Sands website.
13. The Member need not be present during the draw. If the Chosen Number Combination on the Member's kiosk slip matches the drawn results in either manner illustrated below, he must redeem his prize at any SRL kiosk before 11:59pm on the following day of the draw date.

General Terms and Conditions

1. Terms.

- a. The terms and conditions herein ("General T&Cs"), and any other applicable specific terms and conditions relevant to this "\$1,000,000 Sands Super Lucky Number" promotion ("Other T&Cs"), together with any amendments as may be made from time to time, shall form a legal agreement between Marina Bay Sands Pte. Ltd. ("MBS") and you. By participating in this "\$1,000,000 Sands Super Lucky Number" promotion ("Promotion"), you confirm that you have read, understood and agree to be bound by the General T&Cs and Other T&Cs (collectively, the "Rules"). In the event of any conflict or inconsistency between these General T&Cs and the Other T&Cs, the Other T&Cs will prevail followed by the General T&Cs.

2. Promotion Period.

- a. The period of this Promotion will be from 5 April 2021 through 23 May 2021 ("Promotion Period"). This Promotion will expire at the end of the Promotion Period at which time, no further participation in this Promotion will be permitted.

3. Eligibility and Participation.

- a. MBS reserves the absolute discretion to determine the eligibility of any SRL member who is eligible to participate in the Promotion ("Eligible Participant"). Such determination is final and conclusive, and MBS is not obliged to give any reason for excluding or disqualifying any SRL member from participating in the Promotion. No correspondences will be entertained. Only members in possession of SRL membership cards with their names and photographs printed on the card will be able to participate in the Promotion. All Redemptions/Prizes must be redeemed in person by the specific Eligible Member with the Eligible Member's SRL membership card. By participating in the Promotion, SRL members will be deemed to have read, understood and agreed to be bound by these rules and any other requirements set out in any related promotional material and all amendments, additions, replacements, modifications as may be made from time to time. Eligible Members who fail to comply with any of the Terms & Conditions will have their Redemptions/Prizes forfeited.

 - satisfy any other eligibility criteria ("Qualifying Participant").
- c. If you are not a Qualifying Participant and have participated in this Promotion, MBS reserves the right to disqualify your participation as well as seek the return of any payment, award or prize (including such payment, award or prizes credited to any of your membership accounts with MBS) from you.
- d. MBS further reserves the right to disqualify your participation in this Promotion if:
- you have cheated or committed a fraud;
 - tampered or attempted to tamper with the entry process/operation of this Promotion;

- iii. manipulated or attempted to manipulate the operation of this Promotion; or
- iv. your conduct is in breach of the Rules including providing false information (such as fake accounts, personas or photos) or deliberately withholding information.

4. Prizes, Draws and Collection.

- a. Qualifying Participants who have won prizes as a result of participating in this Promotion (“Winning Participant”) must accept the relevant prize “as is”. Prizes cannot be exchanged for cash, are non-transferable, non-exchangeable, non-reimbursable and may not be sold or used for any commercial purpose, including but not limited to any use for which the Winning Participant would be entitled to collect fees or receive any remuneration.

- b. complying with the Company’s internal policies, any applicable law/regulation and request/direction of any applicable authorities of any relevant jurisdiction that is binding on the Company; and
- c. marketing and advertising the Company’s business within and outside of Singapore. For this purpose, you grant MBS a licence to Use your personal data, including your images and likeness, and waive all claims for payment for such Use.
